**SUBJECT:           EXTEND CONTRACT NO. 012-ZZ03 - SNACK-CAKE

The purpose of the bid, opened on June 24, 1999, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of various items of snack-cake products, for the Food Service Program of the Department of Food and Nutrition. The terms of agreement, as contained in the contract, awarded by the Board on August 25, 1999, and extended on June 21, 2000, and August 22, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods, and if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its second one (1) year extension period. The awardees have agreed to extend for the final ninety (90) day extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for a ninety (90) day period, at the current prices, to provide continuity of services during this period. Staff is in the process of developing a new bid.
