SUBJECT: EXTEND CONTRACT NO. 173-ZZ01M/WBE – FURNITURE

The purpose of the bid, opened on July 6, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of furniture, for various locations. The terms of agreement, as contained in the contract, awarded by the Board on August 23, 2000, and extended on July 11, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods and, if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its first extension period. The awardees have agreed to extend for the final ninety (90) day extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for a ninety (90) day period, at the current prices, to provide continuity of services during this period. Staff is in the process of issuing a new bid with revised specifications.
