**SUBJECT: EXTEND CONTRACT NO. 024-AA10 – ADMINISTRATION OF
 HEPATITIS "B" VACCINE**

COMMITTEE: FINANCIAL AFFAIRS

The purpose of the bid, opened on August 29, 2000, was to establish a contract, to purchase services, at firm unit prices, as may be required, for the administration of Hepatitis "B" vaccine, for the Office of Professional Standards. The terms of agreement, as contained in the contract, awarded by the Board on October 11, 2000, and extended on August 22, 2001, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardee has agreed to extend for the final one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of May 2002, indicated an increase of 1.2%.
