**SUBJECT:           AWARD CONTRACT NO. 138-BB03 – FRESH-DELIVERED  
PIZZA, A LA CARTE**

The purpose of this bid, opened on October 3, 2002, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of fresh-delivered pizza, for the a la carte program at secondary schools, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 130 vendors sent bid forms or card notices of this advertised bid, 22 responded, with 19 bids meeting specifications (not all vendors bid all items), 1 non-responsive bid (Ambar DJ International Corporation, d.b.a. Romanos Pizza, of Homestead, Florida, did not enclose bid proposal form), and 2 bids rejected due to excessive cost.

Inasmuch as all pricing submitted by Piccolo Pizza, of Miami, Florida, and Pilis Food Corporation, of Miami, Florida, is deemed excessive, as determined by the Department of Food and Nutrition, in accordance with SPECIAL CONDITIONS 3. AWARD, of the solicitation, a recommendation is being made to reject those bids.
