**SUBJECT: EXTEND CONTRACT NO. 128-AA03 – STORAGE OF DRY,  
FROZEN AND REFRIGERATED COMMODITIES**

**COMMITTEE: FINANCIAL AFFAIRS**

The purpose of the bid, opened on March 22, 2001, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of storage services for dry, frozen and refrigerated commodities, for the Department of Food and Nutrition Food Service Program. The terms of agreement, as contained in the contract, awarded by the Board on June 20, 2001, provided that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardee has agreed to extend for the first one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of September 2002, indicated an increase of 1.5%.
