The purpose of the bid, opened on August 22, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of carbonated beverages, for the Department of Food and Nutrition a la carte program. The terms of agreement, as contained in the subject bid, awarded by the Board on October 11, 2000, and extended on February 13, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods and, if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its first extension period. The Department of Food and Nutrition has elected not to exercise the final one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for a ninety (90) day period, at the current prices, to provide continuity of services during this period. Staff is in the process of developing a new bid.
