SUBJECT: EXTEND CONTRACT NO. 204-AA07 – TRANSPORTATION FOR SPECIAL NEEDS STUDENTS

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of the bid, opened on June 28, 2001, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of transportation for special needs students, for the Department of Transportation. The terms of agreement, as contained in the contract, awarded by the Board on August 22, 2001, and extended on August 21, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional (1) one year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of March 2003, indicated an increase of 3.0%.
