SUBJECT: PARTIAL AWARD BID NO. 175-CC03 – FOOD ITEMS: FROZEN AND REFRIGERATED II

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of this bid, opened on June 17, 2003, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of frozen and refrigerated foods, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 240 vendors sent bid forms or card notices of this advertised bid, 4 responded, with 3 regular bids and 1 no bid.

Inasmuch as Item 4 - Beef, fine ground, Item 22 - Stuffed meat pockets, Item 25 - Beef and cheese soft taco, Item 27 - Taco, chalupa, Item 29 - Bacon, precooked, Item - 46 - Waffles, frozen, Item 50 - Broccoli florets, Item 52 - Carrots, sliced, Item 53 - Collard greens and Item 59 - Potatoes, frozen, skin-on wedge cut are being held for evaluation, these items will be scheduled for recommendation of award at a future Board meeting.

No bids were received for Item 7A - Chicken wings, using donated commodity products, 14A - Fully-cooked grilled chicken patty, Caribbean jerk flavor, using donated commodity products, Item 15A - Fully-cooked, spicy breaded chicken patty, using donated commodity products, Item 16A - Fully-cooked, breaded chicken patty, using donated commodity products, 17 - Turkey meat, Item 18 - Ham, deli style, Item 19 - Bologna, beef, and 35A - Peanut butter and jelly cup, using donated commodity products. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
