SUBJECT: EXTEND CONTRACT NO. 145-AA05 – ELECTRICAL WIRING DEVICES

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of the bid, opened on April 19, 2001, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of electrical wiring devices, for Maintenance Materials Management stock. The terms of agreement, as contained in the contract, awarded by the Board on August 22, 2001, and extended on July 10, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods, and if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its first extension period. The awardees have agreed to extend for the final ninety (90) day extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, at the current prices, to provide continuity of services, and to benefit from fixed prices, during this period, inasmuch as the Consumer Price Index (CPI), as of May 2003, indicated an increase of 2.1%. Staff is in the process of developing a new bid.
