The Office of Adult/Vocational, Alternative and Community Education Programs submitted a continuation grant application to the Florida Department of Education. The project continues to provide literacy services to incarcerated youth at the Miami-Dade County Boot Camp, Department of Corrections. This is the second year of the multi-year grant award.

Authorization is requested to accept a continuation grant award from the Florida Department of Education in the amount of \$57,000 for family literacy corrections education.

No matching funds are required as a condition to receive grant funding. Funds received will provide hourly personnel, travel to conferences, and educational materials needed for instructional activities at Miami-Dade County Boot Camp.

Official notification of the grant award was received on August 4, 2003, which is after the start of the grant period. Reimbursement of grant-related expenditures is authorized effective July 1, 2003.

## **RECOMMENDED:**

That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

- accept a continuation grant award from the Florida Department of Education for Family Literacy Corrections Education in the amount of \$57,000 for the grant period of July 1, 2003 through June 30, 2004;
- extend this program as authorized through official notification from the granting agency, in order to complete the scope of the program; and
- direct Financial Affairs to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board.
