The construction budget for this project is \$3,139,839. The Base Bid of the low bidder is 2.6% under the budget.

Description

This project is for the new construction of Art and Music suite, media center, E.S.E. drop-off, elevator, fire alarm, P/A system and various Safety-to-Life corrections. Remodeling of existing media center for Bilingual education, two (2) itinerant offices and conference room. Site improvements include new fencing, irrigation and sodding, new electrical room, sewer connection and parking lot expansion. Remodeling includes administration office, interior/exterior painting, replacement of chalkboards and cabinets, partial flooring replacement, group restrooms and various Safety-to-Life corrections. Renovations include various Safety-to-Life corrections.

Deductive Alternates

Alternate No. 1- Fencing.

Alternate No. 2- Irrigation.

Alternate No. 3- Sodding.

This project is scheduled for substantial completion within 430 calendar days of the contract, or on January 22, 2005.

The Project Architect, Architeknic Architects recommended award of the contract to the low bidder, NAC Construction, Inc.

One hundred fifty pre-qualified contractors were notified of this project and fourteen firms picked up plans and specifications.

This project was bid with M.B.E. subcontracting assistance levels of 18% African-American and 6% Women. The recommended contractor has submitted the following M/WBE subcontractors as participants in this project which were reviewed for compliance with overall M/WBE assistance levels of 24%.
