The purpose of this bid, opened on January 22, 2004, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of storage and delivery of dry, frozen and refrigerated commodities, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 9 vendors sent bid forms or card notices of this advertised bid, 3 responded, with 3 regular bids.
