Of the above, the firm of Zyscovich, Inc. (Zyscovich), was the top ranked firm and selected for this contract. Negotiations with Zyscovich regarding fees, scope and other related terms have been successfully completed.

- A. A lump sum fee of \$123,179 has been negotiated for developing several master plan options and final scope definition programs of selected options. The options are to include several sites, among them: Madie Ives Elementary, Dr. Michael M. Krop Senior High, the Board-owned 20 acre site east of Dr. Michael Krop Senior High (the proposed site for State School "RR1" is located at N.E. 207th Street & 14th Avenue, Miami, Florida), and State School "D" (a funded elementary school in this feeder pattern). The services will also include coordination with an adjacent Miami-Dade County Park currently being master planned. The firm will develop a minimum of eight different options.
- B. Additional fees were also negotiated for the following services:
 - A not-to-exceed lump sum fee of \$17,170 for traffic engineering consultant services;
 - additional meetings requested by the Board for scope definition and program sign-off, beyond the agreed to number of meetings, at a fee of \$450/meeting;
 - the principals' rate is set at \$125/hour.

C. Other terms and conditions:

- The provisional multiplier for hourly compensation was limited to 2.45 for any additional work approved by Staff;
- printing cost will be reimbursed on a direct cost basis;
- the Master Plan and Final Scope Definition Programming services are scheduled to be completed by October 20, 2004;
- the agreement may be terminated by the Board, with or without cause, upon thirty (30) days written notice to the consultant. The consultant may terminate the agreement, with cause only, upon thirty (30) days written notice to the Board; and
- the full DCP services will be negotiated and the terms submitted to the Board for approval upon the conclusion of the master planning phase.
