Of the twelve (12) firms interviewed, the following were the five highest ranked firms:

These five firms have been selected by staff to provide DCP services for the eleven (11) new prototypical schools. Of these new schools, staff has assigned a new prototype elementary school (State School "Y1") located at S.W. 160th Avenue & S.W. 144th Street, Miami, Florida, and a nearby new prototype middle school (State School "YY1") located at S.W. 157th Avenue & S.W. 144th Street, Miami, Florida, to the joint venture team of The Brown & Brown Architects/BRPH Companies, J.V. (Brown/BRPH). State School "Y1" is intended to provide relief to Jack D. Gordon Elementary and Dr. Gilbert L. Porter Elementary Schools; whereas, State School "YY1" is intended to provide relief to Hammocks Middle and Herbert A. Ammons Middle Schools.

Negotiations with Brown/BRPH have been successfully completed as follows:

STATE SCHOOL "Y1"

The negotiated lump sum DCP basic services fee for the preparation of a design criteria package and subsequent construction administration for this new prototype elementary school is \$344,500, with an estimated total construction cost of \$9,908,893. The fee represents approximately 3.48% of the total construction cost. A summary of the negotiated basic services fee is as follows:

- A not-to-exceed fee of \$8,000 for a traffic engineering study (Note: Due to the close proximity of these schools, the study will include both sites).
- At the Board's option, a not-to-exceed fee of \$12,000 for a food services consultant.
- At the Board's option, a not-to-exceed fee of \$8,000 for an acoustical consultant.
- At the Board's option, the DCP shall provide a full-time on-site representative during construction, as needed by the Board, at a not-to-exceed rate of \$8,500/month.
- At the Board's option, the DCP shall be paid a not-to-exceed fee of \$350/inspection for threshold inspections.

Other terms and conditions were negotiated as follows:

- The DCP has agreed to a re-use fee of \$5,000.
- The multiplier for hourly compensation is limited to 2.45 for extra work.
- The DCP principals' rate is set at \$100/hour.
- The DCP shall maintain no less than a \$2.0 million professional liability insurance policy with a maximum deductible of \$25,000.
- The Board shall reimburse the DCP for the cost of reproducing Board requested contract documents.

The preliminary scope of work for this project includes the following:

- A new prototype elementary school, based on the Facilities List approved by the Board on October 22, 2003, which will house 1,068 student stations (consisting of approximately 93,397 square feet).
- Site work, concurrency, traffic and off-site utilities improvements.
- Enhanced Hurricane Protection Area (EHPA shelter) improvements, if necessary.

The negotiated lump sum DCP basic services fee for the preparation of a design criteria package and subsequent construction administration for this new prototype middle school is \$480,000, with an estimated total construction cost of \$22,611,326. The fee represents approximately 2.12% of the total construction cost. A summary of the negotiated basic services fee is as follows:

RECOMMENDED: That The School Board of Miami-Dade County, Florida, commission The Brown & Brown Architects/BRPH Companies Joint Venture as Design Criteria Professional (DCP) for a new prototype elementary (State School "Y1") and a new prototype middle school (State School "YY1") Project No. A01030 and A01019, respectively, under

the following terms and conditions:

State School "Y1"

- 1) a lump sum basic services fee of \$344,500, which represents approximately 3.48% of the estimated construction cost of \$9,908,893;
- 2) a not-to-exceed fee of \$8,000 for a traffic engineering study to be utilized for both schools;
- 3) at the Board's option, the DCP will provide the following services: a) a not-to-exceed fee of \$12,000 for a food services consultant; and b) a not-to-exceed fee of \$8,000 for an acoustical consultant;
- 4) at the Board's option, the DCP will also provide the following services during construction: a) up to 85 site visits at a fee of \$250/visit; b) a full-time on-site representative, as needed by the Board, at a not-to-exceed rate of \$8,500/month; and c) threshold inspections at a not-to-exceed fee of \$350/inspection;
- 5) the Board shall reimburse the DCP for the cost of reproducing Board requested contract documents;
- 6) the multiplier for hourly compensation is limited to 2.45 for extra work and the principals' rate is set at \$100/hour;
- 7) an agreed to fee of \$5,000 for future re-use of this prototype design; and
