SUBJECT: RENEWAL OF LEASE AGREEMENT WITH GLADES BASEBALL AND SOFTBALL LEAGUE, INC., FOR THE USE OF THE PLAYFIELD AREA AT GLADES MIDDLE SCHOOL, LOCATED AT 9451 SW 64 STREET

Background

Since August 1997, the School Board (Board) has leased the playfield area at Glades Middle School located at 9451 SW 64 Street, to Glades Baseball and Softball League, Inc. (Glades Baseball), a non-profit organization, for its youth sports program during non-school hours (see location map). Glades Baseball serves approximately 260 children from the surrounding community during the hours of 4:30 p.m. to 10:00 p.m., Monday through Friday, and 9:00 a.m. to 4:00 p.m. on Saturdays. Each child is charged a registration fee of approximately \$110 per season to participate in this program, which fee is used to cover the cost of uniforms, equipment, supplies, trophies, utilities, park maintenance and insurance. Glades Baseball also assists Glades Middle School with its intramural softball program. Glades Baseball has completed its initial one-year term and the sixth of an unlimited number of one-year renewal option periods. The current lease term will expire on June 30, 2004. This proposed renewal represents the seventh of an unlimited number of one-year renewal option periods available under the Lease Agreement. The term of the renewal option period will commence July 1, 2004, and will end June 30, 2005.

Renewal of Lease Agreement

All terms and conditions of the Lease Agreement will remain unchanged, including the following:

- annual lease rate of \$1.00;
- Glades Baseball is responsible for providing electricity to light the baseball fields, for maintenance and repair of all recreational facilities and for the removal of litter and trash;
- the District is responsible for mowing the outfield and for providing water and electricity to irrigate the grounds; and
- either party may cancel at any time by giving the other 90 days prior written notice.

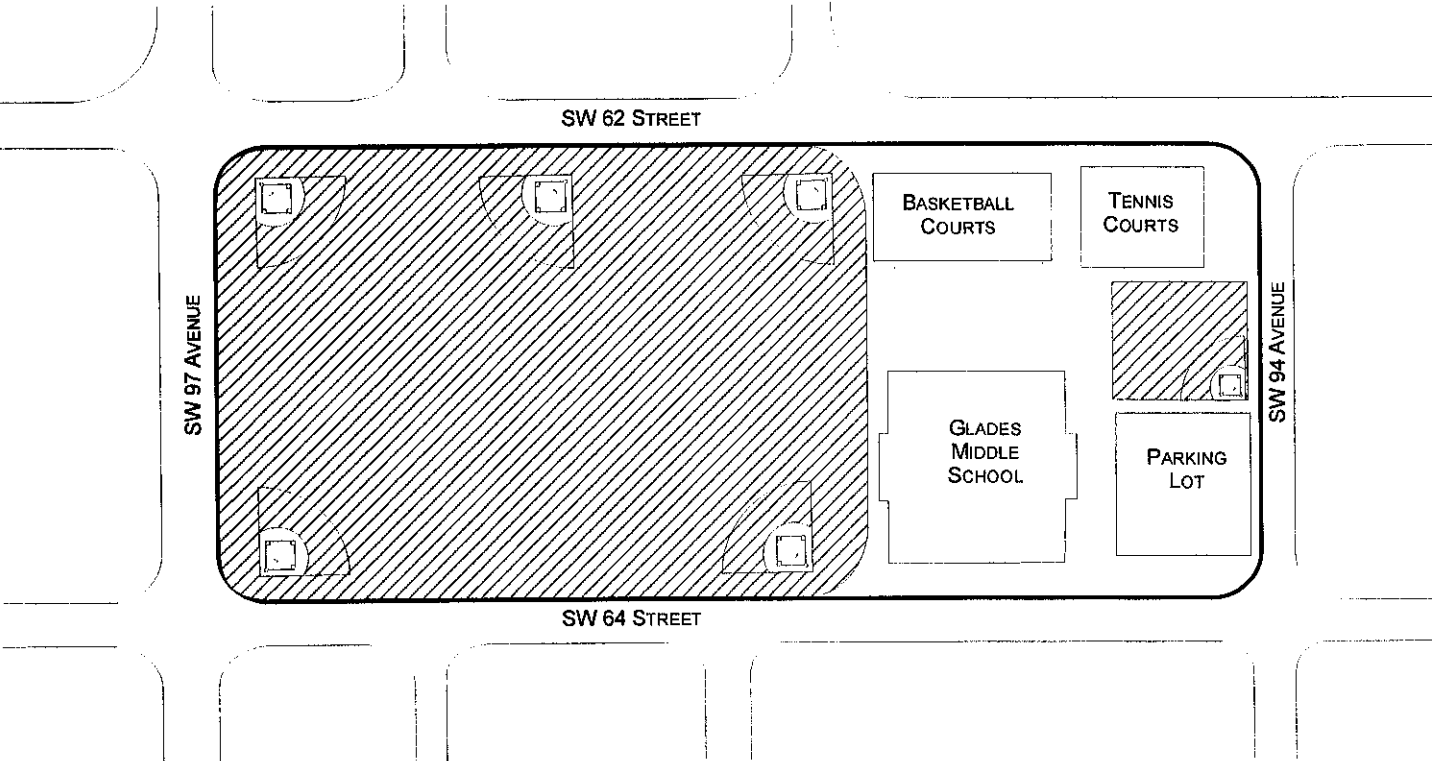
Staff contacted the Principal of Glades Middle School, the Associate Superintendent of ACCESS Center 5, and the Associate Superintendent of ACCESS Centers, who approved Glades Baseball's request to renew the lease term for an additional one-year period.

RECOMMENDED:


That The School Board of Miami-Dade County, Florida, authorize the renewal of the Lease Agreement with Glades Baseball and Softball League, Inc., for use of the playfield area at Glades Middle School, at an annual rental rate of \$1.00. The term of the renewal option period will commence July 1, 2004, and will end June 30, 2005. All other terms and conditions of the Lease Agreement will remain unchanged.
