**SUBJECT: CORRECT, RESCIND, RE-AWARD AND BALANCE OF AWARD ON  
BID NO. 081-DD03 – VENDING-MACHINE FEE PROGRAM FOR  
SENIOR HIGH SCHOOLS, STUDENT ACCESS**

**COMMITTEE: BUSINESS AND FINANCIAL SERVICES**

This contract was awarded by the Board on July 14, 2004, to provide vending-machine service to all senior and vocational high schools, at a firm annual access fee for senior and vocational high schools, paid to Miami-Dade County Public Schools.

Inasmuch as the July 14, 2004, Board agenda Item G-69, incorrectly reflected the award of Item 114 - Miami Springs Senior High, snack/food merchandise @ \$37,500 annual access fee, this Board item reflects a correction of award to \$32,500. This correction adjusts the annual access fee paid to Miami-Dade County Public Schools from Gilly Vending, Inc. to \$1,260,800.

Subsequent to the award of the bid, Interstate Beverage Corporation indicated that they are unable to accept the bid award, and have elected, by letter, on file, to lose eligibility to transact new business with the Board for a period of fourteen (14) months. The primary award for these items is recommended to the second highest annual access fee submitted by Coca-Cola Enterprises, Inc. for Item 36, and Pepsi Bottling Group for Item 37.

Primary vendors were awarded by the Board on July 14, 2004, for an estimated annual revenue to the District's senior and vocational high schools in the amount of \$2,753,892.
