SUBJECT: PARTIAL AWARD BID NO. 085-DD08 – ART SUPPLIES

The purpose of this bid opened on May 18, 2004, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of art supplies, for Stores and Mail Distribution stock. This is a term bid which states that the Board may purchase quantities, as may be required, at firm unit prices, but is not obligated to purchase any guaranteed amount. Of 89 vendors sent bid forms or card notices of this advertised bid, 24 responded, which includes 4 non-responsive bids and 2 no bids.

Items 2, 4 through 7, 10 through 16, 18, 32, 33, 35, 37, 41, 44, 46, 52, 54, 56, 64, 65, 69, 70, 72 through 75, 88, 92, 94, 97, 100 through 102, 109, 110, and 113 through 116 are being held for evaluation and will be scheduled for recommendation of award at a future Board meeting.

No bids were received for Items 38 - Sketchbook, Item 42 - Blending stump, Item 77 - Batix wax and Item 119 - Speedball painters. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
