Staff has completed the selection process for Design Criteria Professional (DCP) firms to prepare design criteria packages for eleven (11) new prototypical schools listed under the 2003-2004 District Facilities Five-Year Work Program. Each school will be designed/constructed using the design-build delivery method.

These five firms have been selected by staff to provide DCP services for the eleven (11) new prototypical schools. Of these new schools, staff has assigned a new prototype senior high school (State School "BBB1") to Zyscovich, Inc. (Zyscovich). State School "BBB1" is intended to replace and be built at the existing site of North Miami Senior High School.

Negotiations with Zyscovich to prepare a final scope/program validation for State School "BBB1" have been successfully completed as noted below. The planning funds for this project were allocated for FY 03-04, the design funds for FY 04-05, and the construction funds for FY 05-06.

### TERMS AND CONDITIONS

- A. A negotiated lump sum fee of \$56,000 was agreed to for preparing the final scope/program validation.
- B. Other terms and conditions:
  - A lump sum fee of \$3,500 for a traffic engineering analysis.
  - A lump sum fee of \$450 for each additional final scope/program validation signoff meeting beyond the two meetings included as part of basic services.
  - The cost of printing will be reimbursed by the Board on a direct cost basis.
  - The principals' rate is set at \$125/hour.
  - The provisional multiplier for hourly compensation is limited to 2.45 for any additional work approved by staff.
  - The agreement may be terminated by the Board, with or without cause, upon thirty (30) days written notice to the DCP; whereas, the DCP may terminate the agreement, with cause only, upon thirty (30) days written notice to the Board.
  - The final scope/program validation is scheduled to be completed by November 5, 2004.

# PROJECT SCOPE

The final scope, budget and schedule for design and construction of State School "BBB1" will be established during this initial validation phase. The fee for preparing the design criteria package for this project (including Phase I – 100% documents) will be negotiated by staff upon conclusion of the final scope/program validation phase.

The negotiated terms and conditions for preparing the design criteria package will be submitted to the Board for its approval.
