SUBJECT: REQUEST AUTHORIZATION TO ACCEPT A GRANT AWARD

FROM THE FLORIDA DEPARTMENT OF EDUCATION (FLDOE) FOR FUNDING THE TITLE IV COMMUNITY SERVICE PROGRAM

AT ALLAPATTAH MIDDLE SCHOOL

COMMITTEE: EDUCATION AND SCHOOL OPERATIONS

Under the No Child Left Behind Act of 2001, the Florida Department of Education (FLDOE) Title IV Community Service Program awards grants through a statewide, competitive process to support participation in structured service programs for K-12 students who are suspended, expelled, or in alternative programs in lieu of expulsion.

Authorization is requested to accept a grant award from the FLDOE, in the amount of \$43,175, to fund the community service program at Allapattah Middle School for the grant period of July 1, 2004 through June 30, 2005. This is the second year of this award.

The grant will provide an after-school and Saturday program for at-risk youth. The program instructors will receive professional development in teaching character development, behavior modification, and how to cope with problems of school violence, drug abuse, and other issues of concern to middle school students. Students will be immersed in an intensive program aimed at building leadership skills and self-esteem. As a culminating activity for each grading period, students will organize and make a presentation to educate elementary school students within the Allapattah Middle School feeder pattern.

An in-kind match is required to receive these funds. The match request, valued at \$32,821 is met by salaries, building facilities, and PTSA contributions. Grant funds in the amount of \$41,146 will be used for hourly employees, overtime, supplies, textbooks, audiovisual materials, pupil transportation, and out-of-county travel. Indirect cost is \$2,029, for a total of \$43,175.

Official notification of this grant was received on August 9, 2004, which is after the start of the grant period. Reimbursement of grant-related expenditures is authorized effective July 1, 2004.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

- 1. accept a grant award from the Florida Department of Education (FLDOE) for funding the Title IV Community Service Program at Allapattah Middle School in the amount of \$43,175 for the grant period of July 1, 2004 through June 30, 2005;
- extend this program as authorized through official notification from the granting agency in order to complete the goals of the program; and
- 3. direct Financial Operations to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board.
