REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR UNITED CEREBRAL PALSY OF SOUTH FLORIDA CHARTER SCHOOLS, INC., ON BEHALF OF EARLY BEGINNINGS ACADEMY – NORTH SHORE AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL

AGREEMENT FOR A TERM OF FIVE YEARS

As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On October 4, 2004, M-DCPS Charter School District Review Committee met to review the application for Early Beginnings Academy – North Shore and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 58 Pre-kindergarten students in Exceptional Student Education programs, with a maximum of 31 students in its first year of operation, commencing with the 2005-2006 school year, at a facility to be located at 1100 NW 95 Street, Miami, Florida 33150.

The following is the Founding Board for the charter school: Dr. Joseph A. Aniello, Educational Administrator and Executive; Dr. Debbie Terenzio, Educational Administrator; Dr. Leigh Kapps, Educational Administrator; Ms. Linda Gluck, Accountant; Ms. Kathleen T. Kelly, Human Resources Director; Mr. Roy R. Lustig, Attorney; Mr. Manuel Machin, Real Estate Consultant; Mr. Dwight Stephenson, Businessperson; Ms. Marta E. Morin, Educator; Ms. Ilene E. Wilkins, Businessperson; and Mr. Jack Schillinger, Retired Businessperson.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on district schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- 1. approve the application for United Cerebral Palsy of South Florida Charter Schools, Inc., on behalf of Early Beginnings Academy - North Shore; and
- 2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2005-2006 school year through the conclusion of the 2009-2010 school year, which reflects the contents of the application as approved by the School Board.
