REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR LICEO ENLACE MIAMI! CHARTER ACADEMY, INC., ON BEHALF OF LICEO ENLACE MIAMI! CHARTER ACADEMY AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL AGREEMENT FOR A TERM OF FIVE YEARS

As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On October 4, 2004, M-DCPS Charter School District Review Committee met to review the application for Liceo ENLACE Miami! Charter Academy and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 1,175 students in grades kindergarten through twelve, with 375 students in grades kindergarten through four in its first year of operation, commencing with the 2005-2006 school year, at a facility to be located close to the Florida International University College of Engineering within the Sweetwater/Westchester community.

The following is the Founding Board for the charter school: Dr. Gustavo Roig, Educator; Dr. Lucy Puello-Capone, Educator; Dr. Judith S. Stein, Educator; Dr. Hui Fang Huang "Angie" Su, Educator; and Dr. Tsung-Chow (Joe) Su, Educator.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on district schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- 1. approve the application for Liceo ENLACE Miami! Charter Academy, Inc., on behalf of Liceo ENLACE Miami! Charter Academy; and
- 2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2005-2006 school year through the conclusion of the 2009-2010 school year, which reflects the contents of the application as approved by the School Board.
