REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR EBENEZER CHARTER SCHOOL, INC., ON BEHALF OF EBENEZER CHARTER SCHOOL AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL

AGREEMENT FOR A TERM OF FIVE YEARS

As established in School Board Rule 6Gx13- <u>6A-1.47</u>, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On October 4, 2004, M-DCPS Charter School District Review Committee met to review the application for Ebenezer Charter School and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 200 students in grades kindergarten through five, with a maximum of 100 students in grades kindergarten through three in its first year of operation, commencing with the 2005-2006 school year, at a facility to be located at 2000 NW 35 Street, Miami, Florida 33142.

The following is the Founding Board for the charter school: Dr. Jimmie L. Brown, Law Enforcement Officer and Religious Leader; Ms. Eloise B. Johnson, Retired Educator; Dr. Christina M. Eve, Retired Educator; Dr. Geraldine Gillard-Ingraham, Retired Educator; Ms. Francena A. Scott, Retired Educator; Mr. William Francis, Military Veteran; Ms. Aggie Reed, Accountant; Mr. Timothy Smith, Businessperson; Mr. Carlos, Diaz, Community Resident; and Dr. Richard J. Strachan, Retired Educator.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on district schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- 1. approve the application for Ebenezer Charter School, Inc., on behalf of Ebenezer Charter School; and
- 2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2005-2006 school year through the conclusion of the 2009-2010 school year, which reflects the contents of the application as approved by the School Board.
