REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR MATER ACADEMY, INC., ON BEHALF OF MATER PERFORMING ARTS AND ENTERTAINMENT ACADEMY AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL AGREEMENT FOR A TERM OF TEN YEARS

As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On October 13, 2004, M-DCPS Charter School District Review Committee met to review the application for Mater Performing Arts and Entertainment Academy and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 200 students in grades nine through twelve, with a maximum of 100 students in grades nine and ten in its first year of operation, commencing with the 2005-2006 school year, at a facility to be located at 7901 NW 103 Street, Hialeah Gardens, Florida 33016.

The following is the Founding Board for the charter school: Mr. David Concepcion, Legislative Aide; Dr. Ruth Jacoby, Educator; Mr. Henri Pferdmenges, Entrepeneur and Banker; Mr. Antonio Roca, Attorney; and Mts. Shannine Sadesky, Educator.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on district schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- approve the application for Mater Academy, Inc., on behalf of Mater Performing Arts and Entertainment Academy; and
- 2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of ten years, commencing with the 2005-2006 school year through the conclusion of the 2014-2015 school year, which reflects the contents of the application as approved by the School Board.
