REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR DORAL ACADEMY HIGH SCHOOL, INC., ON BEHALF OF DORAL PERFORMING ARTS AND ENTERTAINMENT ACADEMY AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL AGREEMENT FOR A TERM OF TEN YEARS

As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On October 13, 2004, M-DCPS Charter School District Review Committee met to review the application for Doral Performing Arts and Entertainment Academy and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 200 students in grades nine through twelve with a maximum of 100 students in grades nine and ten in its first year of operation, commencing with the 2005-2006 school year, at a facility to be located at 11100 NW 27 Street, Doral, Florida 33172.

The following is the Founding Board for the charter school: Ms. Salima Abello, Educator; Ms. Gabrielle Alvarez, Doral Resident; Mr. Victor Barroso, Businessperson; Ms. Ana Carbonell, Congressional Staffer; and Ms. Millie Fresen, Broadcasting Executive.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on district schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- 1. approve the application for Doral Academy High School, Inc., on behalf of Doral Performing Arts and Entertainment Academy; and
- 2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of ten years, commencing with the 2005-2006 school year through the conclusion of the 2014-2015 school year, which reflects the contents of the application as approved by the School Board.
