In 1967, Congress passed the Public Broadcasting Act which established the Corporation for Public Broadcasting (CPB). The CPB is a private, nonprofit organization that funds over 1,000 public television and radio stations nationwide using an annual appropriation from Congress. Allocations to public broadcasting stations are computed based upon a formula which uses a station's non-federal financial support.

Authorization is requested to accept a grant award from the CPB in the amount of \$1,130,853 to fund the Television Community Service Program for WLRN-TV for the grant period of October 1, 2004 through September 30, 2006.

No matching funds are required as a condition to receive the grant funding. Grant funds in the amount of \$1,130,853 will be used to support personnel and operations of WLRN-TV. Indirect cost is not allowed.

Official notification of this grant award was received on September 30, 2004. Reimbursement of grant-related expenditures is authorized effective October 1, 2004.
