**SUBJECT:       REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER SCHOOL APPLICATION FOR SANDOR WIENER SCHOOL OF OPPORTUNITY, INC., ON BEHALF OF SANDOR WIENER SCHOOL OF OPPORTUNITY SOUTH AND AUTHORIZATION TO NEGOTIATE A CONTRACTUAL AGREEMENT FOR A TERM OF FIVE YEARS**

**COMMITTEE:    EDUCATION AND SCHOOL OPERATIONS**

As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On October 11, 2004, M-DCPS Charter School District Review Committee met to review the application for Sandor Wiener School of Opportunity South and by a majority vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 36 students in Exceptional Student Education programs in grades Pre-kindergarten through five, commencing with the 2005-2006 school year, at a facility to be located at 11025 SW 84 Street, Miami, Florida 33173.

The following is the Founding Board for the charter school: Ms. Helen Salazar-Realini, Financial Planner; Mr. Lawrence Wiener, Investor and Banker; Dr. William D. Kirsh, Physician; Mr. Paul B. Feltman, Attorney; Ms. Bethany Sands, Consultant; Mr. Michael Messer, Business Executive; and Ms. Vickie Burley, Educator.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on district schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida:

2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2005-2006 school year through the conclusion of the 2009-2010 school year, which reflects the contents of the application as approved by the School Board.
