As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) received charter school applications from individuals and/or organizations in the community.

On December 3, 2004, M-DCPS Charter School District Review Committee met to review the application for Bridge Academy and by a majority vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 1,000 13<sup>th</sup> Year students (12<sup>th</sup> grade students needing to pass the FCAT), with a maximum of 240 students in its first year of operation, commencing with the 2005-2006 school year at a facility located at 115-117 NE 54 Street, Miami, Florida 33137. Based on need, the school also proposes to serve students in a facility in the Homestead area.

The following is the Founding Board for the charter school: Bernardo A. Garcia, Educational Consultant; Jean-Rene Foureau, Educator; Jonathan L. Fried, Community Activist; Leo S. Cardona, Educator; and Georges Magny, Educator.

Any pending issues identified by the Charter School District Review Committee in the recommended application, including minimizing the impact on District schools that are under-enrolled, will be addressed satisfactorily in the development of the charter school contractual agreement. The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.
