The purpose of this bid, opened on November 23, 2004, is to purchase, at firm unit prices, quantities, as may be required, of charter-bus services, in and out of county, for various schools and departments. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 88 vendors sent bid forms or card notices of this advertised bid, 16 responded, with 14 regular bids, 1 non-responsive bid and 1 no bid.
