The combined resources of Miami-Dade County Public Schools (M-DCPS) and BACC have resulted in the delivery of comprehensive services to SED and EH students placed in psycho-educational day treatment programs at M-DCPS sites. This cooperative agreement has been in effect since 1981.

Miami-Dade County Public Schools provides facilities, teachers, materials, supplies, and transportation. Services provided to EH and SED students by BACC include expressive arts, individual and group therapy, crisis intervention, family counseling, parent education, home visits, in-home interventions, on-going staff training, and referral services, as required by each student's Individual Educational Plan (IEP). In addition, psychiatric consultation services are provided for EH and SED students, as needed. BACC provides input into the hiring of instructional personnel; however, the authority rests with the school-site administrator to make final personnel decisions.

The Executive Director of Bertha Abess Children's Center, Inc., is Ms. Carolyn Jenkins-Jaeger.

As established in School Board Rule 6Gx13- 6A-1.48, K-8 Centers, Miami-Dade County Public Schools (M-DCPS) received an application from the Devon Aire Elementary School Parent Teacher Association (PTA) and Educational Excellence School Advisory Committee (EESAC).

On December 2, 2004, the M-DCPS K-8 Center Administrative Committee met to review the application and by a unanimous vote made a recommendation for approval of the application to the Superintendent of Schools.

Devon Aire Elementary School, which currently serves 917 students in grades K through 5, projects that the school would serve 300 to 450 additional students in grades 6 through 8 as soon as the appropriate addition to the facility can be constructed.
