As a result of the extended school day, the dismissal time of the extended school day conflicted with the availability of in-house resources to provide this service. Consequently, contracted services were required to provide transportation services for students at these School Improvement Zone locations. Due to the short notice for implementation, a formal bid was issued on an emergency basis, and thirty-one (31) out of thirty-eight (38) runs were covered by private school-bus companies. However, in-house resources were identified to cover these seven (7) routes not awarded by this emergency.	\$366,044
