At its meeting of July 14, 2004, the Board commissioned Pirtle Construction Company as CM-at-Risk for "one, two or more story prototype additions". This contract provides for construction services to the Board and a Guaranteed Maximum Price (GMP) for construction.

The GMP for the new office, resource, training and testing center, by the Construction Manager, Pirtle Construction Company is \$2,632,541 (contingency included \$239,322). The Project Architect's estimate is \$3,230,460 and the independent cost estimate is \$2,939,814. This GMP covers all required work and includes subcontracts, materials, contingency, general conditions, bond, and overhead and profit.

This project is a 13,890 square foot IDEA Grant funded building to replace a portable facility. The new facility is comprised of a training center, library, audiology testing suite, office spaces and restrooms.
