**SUBJECT:           REQUEST AUTHORIZATION TO ACCEPT THREE GRANT AWARDS FROM THE FLORIDA DEPARTMENT OF EDUCATION (FLDOE) FOR FUNDING THE MULTIAGENCY SERVICE NETWORK FOR STUDENTS WITH SEVERE EMOTIONAL DISTURBANCE (SEDNET) PROJECT UNDER THE INDIVIDUALS WITH DISABILITIES EDUCATION ACT (IDEA), PART B; IDEA PART B TRUST; AND STATE GENERAL APPROPRIATIONS REVENUE FUNDS**

The Florida Department of Education (FLDOE) has awarded the Miami-Dade County Public Schools (M-DCPS) three entitlement grants for the Multiagency Service Network for Students with Severe Emotional Disturbance (SEDNET). The SEDNET project, one of 18 statewide, was established through the enactment of Section 230.2317, Florida Statutes. M-DCPS is responsible for the fiscal and administrative management of the project, and serves a target population of severely emotionally disturbed students in both M-DCPS and Monroe County Public Schools.

Authorization is requested to accept three grant awards from the FLDOE in the approximate amount of \$156,925 to fund the Multiagency Service Network for students with Severe Emotional Disturbance (SEDNET) Project for the grant period of July 1, 2005, through August 31, 2006.

SEDNET provides coordination of children's mental health services through staff development, pilot projects to expand school-based mental health services, facilitation of a school-to-work grant, and case management to reduce dropout and in-school and out-of-school suspension.

Funds in the amount of \$156,925 have been allocated from the following sources:

- \$123,613 from IDEA, Part B, and IDEA Part B Trust
- \$ 33,312 from State General Appropriations Revenue Funds.

No matching funds are required as a condition to receive this grant funding. Grant funds in the amount of \$151,841 will be used for personnel, printing, supplies, and duplicating. The indirect cost is \$5,084, for a total allocation of \$156,925.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the Florida Department of Education (FLDOE) for funding under the Individuals with Disabilities Education Act (IDEA), Part B, in the approximate amount of \$123,613; and State General Appropriations Revenue Funds, in the approximate amount of \$33,312, for the approximate total amount of \$156,925, for the grant period of July 1, 2005, through August 31, 2006;
2. extend this program as authorized through official notification from the granting agency in order to complete the goals of the program; and
3. direct Financial Operations to establish appropriations in the amounts approved or as amended by the granting agency, such appropriations to be reported periodically to the Board.

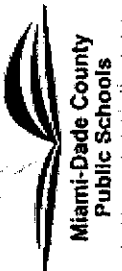
