**SUBJECT:           REQUEST AUTHORIZATION TO ACCEPT A GRANT AWARD  
FROM THE NATIONAL ENDOWMENT FOR THE ARTS FOR  
FUNDING UNDER LEARNING IN THE ARTS FOR CHILDREN &  
YOUTH PROGRAMS AT THE NEW WORLD SCHOOL OF THE  
ARTS**

**COMMITTEE:       INSTRUCTIONAL EXCELLENCE & COMMUNITY ENGAGEMENT**

The New World School of the Arts has been awarded a grant in the amount of \$42,500 by the National Endowment for the Arts through a competitive process. The purpose of this grant is to support the development of a school-based, artists-in-residency program that shares South Florida's ethnic cultures through dance, theatre, music, and the visual arts.

Authorization is requested to accept a grant award from the National Endowment for the Arts for funding under Learning in the Arts for the Children & Youth Programs at the New World School of the Arts in the amount of \$42,500, for the grant period of August 1, 2005, through May 31, 2006.

The primary goal of the National Endowment for the Arts is to provide national recognition of the importance of the arts and to support artistic programs that preserve and enhance the nation's diverse cultural heritage. Additionally, the agency is committed to helping children and youth acquire knowledge, skills, and understanding of the arts as the foundation for a lifetime of arts exposure. The goals of the National Endowment for the Arts are aligned with the goals of the New World School of the Arts and the District Strategic Plan.

The grant was advertised on the National Endowment of the Arts website. All public schools K-12 and consortium organizations were eligible to apply for this grant opportunity.

No matching funds are required as a condition to receive the grant funding. Grant funds will be used for contractual agreements with visiting artists and the project will be managed by the Division of Life Skills and Special Projects.

Notification of this grant award was received on July 25, 2005. Reimbursement of grant- related expenditures is authorized effective August 1, 2005.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the National Endowment for the Arts for funding under the Learning in the Arts for Children & Youth Program at the New World School of the Arts, in the amount of \$42,500, for the grant period of August 1, 2005, through May 31, 2006;
2. extend this program as authorized through official notification from the granting agency, in order to complete the goals of the program; and
3. direct Financial Operations to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board.
