SUBJECT: AWARD BID NO. 063-EE09 – WASTEWATER TREATMENT FACILITIES – OPERATE AND MAINTAIN

COMMITTEE: FACILITIES AND CONSTRUCTION REFORM

The purpose of this bid, opened on September 8, 2005, is to establish a contract to furnish, at firm unit prices, the necessary personnel, all labor, supervision, materials, equipment, services, permits, licenses and insurance, and transportation, to operate and maintain wastewater-treatment plants, at Pinecrest Elementary School, and the Redland plant which serves Redland Elementary and Redland Middle Schools, Redland Vehicle Maintenance Facility, and Region Maintenance Center 6, for Regulatory Compliance. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 115 vendors sent bid forms or card notices of this advertised bid, 1 responded; however, historically, three vendors have submitted a response for this service.

In situations where only one bid was received, the Board has requested additional information. Included with each bid is a form requesting information as to why the vendor chose not to submit a bid. No vendors returned this form.

- Item 1A - Pincrest Elementary School, perform wastewater treatment plant maintenance and all required testing, six (6) days per week, and a minimum of thirty (30) minutes per day @ \$2,750 per month.
 - Item 1B - Pincrest Elementary School, pumping and disposal service @ \$.16 per gallon.
 - Item 1C - Pincrest Elementary School, additional services (labor only) @ \$45 per hour.
 - Item 2A - Redland Schools, perform wastewater treatment plant maintenance and all required testing, six (6) days per week, and a minimum of thirty (30) minutes per day @ \$2,550 per month.
 - Item 2B - Redland Schools, pumping and disposal service @ \$.16 per gallon.
 - Item 2C - Redland Schools, additional services (labor only) @ \$45 per hour.
 - Item 3 - Parts and supplies markup @ 20% (\$30,000 estimated annual parts and supplies expenditures).
