**SUBJECT: TERMINATE AND RE-AWARD CONTRACT NO. 061-EE10 –  
RELOCATION OF FURNITURE, FIXTURES AND EQUIPMENT**

**COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS**

This contract was awarded by the Board on August 17, 2005, to purchase services, at firm unit prices, for the relocation, assembly, installation and setup, of new and existing office and school classroom furniture and specified fixtures and equipment. Five pre-qualified vendors were awarded this contract. The awarded vendors are invited to participate in the quoting process for each relocation project.

Subsequent to the award, one of the awardees, Beltmann Group, of Pompano Beach, Florida, advised Procurement Management Services, that they wish to withdraw their services, at the conclusion of any awarded projects, due to ongoing scheduling conflicts. The vendor is unable to attend the required scope meetings to quote on projects. Since this contract pre-qualifies vendors to participate in the quoting process for projects, the below recommendation reflects that the Board not implement the prescribed default provision as noted in Board Rule 6Gx13- 3C-1.08 -- Performance and Payment Security, Declining a Bid Award, and Bonding Company Qualifications, on Beltmann Group.
