Governor Jeb Bush signed House Bill 0803 into law effective in the year 2003, designating the month of January, annually, as Florida Jewish History Month. The purpose of Florida Jewish History Month is to call attention to the many cultural, social, professional and economic contributions of Florida's Jewish community not only to the state of Florida but also to the United States.
