**SUBJECT: REQUEST SCHOOL BOARD APPROVAL OF THE CHARTER
 SCHOOL APPLICATION FOR THE EXCEL ACADEMY, INC., ON
 BEHALF OF EXCEL ACADEMY CHARTER SCHOOL NORTH AND
 AUTHORIZATION TO NEGOTIATE A CONTRACTUAL
 AGREEMENT FOR A TERM OF FIVE YEARS**

COMMITTEE: INSTRUCTIONAL EXCELLENCE AND COMMUNITY ENGAGEMENT

As established in School Board Rule 6Gx13- 6A-1.47, Charter Schools (K-12), Miami-Dade County Public Schools (M-DCPS) has received charter school applications from individuals and/or organizations in the community.

On October 6, 2005, M-DCPS Charter School District Review Committee met to review the application for Excel Academy Charter School North and by a majority vote made a recommendation for approval of the application to the Superintendent of Schools.

The charter school proposes to serve a maximum of 700 students in grades kindergarten through five, with 250 students in grades kindergarten through two in its first year of operation commencing with the 2006-2007 school year and through the conclusion of the 2010-2011 school year.

The following is the Founding Board for the charter school: Patricia Grimsley, Educational Administrator; Rodney Baltimore, Community Activist/Radio Announcer; Deborah E. Robinson, Mental Health Professional; Charles E. Brown, Civil Servant; Lyvie Fatal, Social Worker; Cheretha Berrieum, Educator/Businessperson; David Shorter, Civil Servant; Annie Ruth Brown, Educator; Kenneth A. Duke, Cleric; Tommy Ford, Actor; Anita Sandler, Educational Administrator; Robert E. Weisberg, Attorney; and Erika Thomas, Community Member.

The charter school contractual agreement will be submitted for School Board consideration at a subsequent meeting at which time there will be a public hearing to provide for community input.

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

1. approve the application for The Excel Academy, Inc., on behalf of Excel Academy Charter School North; and
2. authorize the Superintendent to negotiate a charter school contractual agreement for a term of five years, commencing with the 2006-2007 school year and through the conclusion of the 2010-2011 school year, which reflects the contents of the application as approved by the School Board.
