REQUEST AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE CITY OF MIAMI BEACH FOR FUNDING UNDER THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FOR THE SUPER STARS AFTER-SCHOOL CARE PROGRAM AT MIAMI BEACH ADULT AND COMMUNITY EDUCATION CENTER

COMMITTEE: INSTRUCTIONAL EXCELLENCE AND COMMUNITY ENGAGEMENT

Authorization is requested to accept a grant award from the City of Miami Beach, in the amount of \$20,000, to fund the Miami Beach Adult and Community Education Center – Super Stars After-School Care Program for the grant period of October 1, 2005, through September 30, 2006. The City of Miami Beach, Housing and Community Development Division, provides funding under the Community Development Block Grant (CDBG) program through a competitive grant process to eligible agencies providing services that benefit low and moderate income persons. Miami Beach Adult and Community Education Center applied for and received a CDBG grant. The program will be managed by Miami Beach Adult and Community Education Center.

The purpose of this grant is to enhance the existing Super Stars After-School Care Program. The program helps remediate and expand students' individual knowledge base, through academic, computer, recreational, art and cultural programs, along with health fitness and nutritional activities. This program serves families with school-age children residing in the City of Miami Beach.

No matching funds are required as a condition to receive the grant award. Grant funds in the amount of \$20,000 will be used for hourly personnel, materials, and field trips. Indirect cost is not allowed.

Official notification of this grant award was received on June 14, 2005. Reimbursement of grant-related expenditures is authorized effective October 1, 2005.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

- 1. accept a grant award from the City of Miami Beach for funding the Miami Beach Adult and Community Education Center Super Stars After-School Care Program, in the total amount of \$20,000, for the grant period of October 1, 2005, through September 30, 2006;
- 2. extend this program as authorized through official notification from the granting agency in order to complete the goals of the program; and
- 3. direct Financial Operations to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board.
