**SUBJECT: AWARD BID NO. 030-FF07 – GASOLINE AND DIESEL FUEL #2
(LOW SULFUR), NORTH AND SOUTH OF FLAGLER STREET,
TRANSPORT DELIVERY**

COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS

The purpose of this bid, opened on November 8, 2005, is to purchase, at firm service charges, with escalation/de-escalation of fuel prices based on the OPIS average rack price for fuel, quantities, as may be required, of gasoline and diesel fuel #2 (low sulfur), north and south of Flagler street, transport delivery, for the Department of Transportation. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit service charge, but is not obligated to purchase any guaranteed amount. Of 18 vendors sent bid forms or card notices of this advertised bid, 4 responded, with 3 regular bids and 1 no bid.

The District's bid was benchmarked against Miami-Dade County's fuel prices for the week of November 6, 2005, through November 12, 2005, and the results indicated that the District is receiving better prices for diesel fuel #2 and gasoline (approximately \$.04 lower per gallon on diesel fuel and approximately \$.10 lower per gallon on gasoline).
