**SUBJECT: PROPOSED AMENDMENT OF SCHOOL BOARD RULE: FINAL
READING 6Gx13- 3E-1.10, TRANSPORTATION – SPECIFIC
PROCEDURES**

COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS

The School Board of Miami-Dade County, Florida, announced on October 19, 2005, its intention to amend School Board Rule 6Gx13- 3E-1.10, Transportation - Specific Procedures, and the document, School Bus Transportation Rules and Policies Manual, which is incorporated by reference and made part of this rule, at the meeting of December 14, 2005. The document is used as a reference guide to specify operational procedures related to issues such as school bus route development, student eligibility and field trips.

The manual currently provides for an alternate afternoon drop off location for special needs students within prescribed guidelines. The proposed change will permit certain non-disabled students to similarly be permitted an alternate drop off location in the afternoon providing the change does not entail a change in route nor bus assignment of the student; the change transports the student to a program or activity approved by the School Board; the change *does not* increase the mileage for the run by more than .75 mile, the riding time for other students assigned to the bus by more than eight minutes, or the total time for the run in excess of 50 minutes. The routing change is cost-neutral to the district.

The Notice of Intended Action was published in the *Miami Daily Business Review* on October 21, 2005, posted in various places for public information, and mailed to various organizations representing persons affected by the amended rule and to individuals requesting notification.

The time to request a hearing or protest the adoption of this rule has elapsed.

In accordance with the provisions of the Administrative Act, this amended rule is presented to The School Board of Miami-Dade County, Florida, for adoption and authorization to file the rule in the official records of the School Board of Miami-Dade County.

Attached are the Notice of Intended Action, the rule proposed for amendment, and the document, School Bus Transportation Rules and Policies Manual. Changes from the current rule are indicated by underscoring words to be added and ~~striking through~~ words to be deleted.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida, adopt amended Board Rule 6Gx13- 3E-1.10, Transportation – Specific Procedures, and the document, School Bus Transportation Rules and Policies Manual, which in incorporated by reference and made part of this rule, and authorize the Superintendent to file the rule with The School Board of Miami-Dade County, Florida, to be effective December 14, 2005.

PURPOSE AND EFFECT: To allow regular (non-special needs) students to be transported to a different bus stop after school as compared to the morning drop-off location if the change in bus stop meets the criteria set forth in the Transportation Rules and Policies Manual.

SUMMARY: The requested change in this Board Rule would allow students who are not enrolled in the school district's ESE programs to also benefit from these provisions if the different afternoon bus stop also meets the requirements set forth in the Manual.
