JESCA provides many social services including alternative education programs for students unable to succeed in the public schools. During the 2004-05 school year, 196 Miami-Dade County students participated in JESCA's program. Total program funding for the School District funded "Roving Leaders Program" was reportedly \$1,019,399.

JESCA's financial statements reflected large bank overdrafts and bank charges. There was a decrease in net assets as a result of operations in Fiscal Year 2004. Their auditor's also reported matters concerning internal controls over operation that they considered material weaknesses. Upon request, the JESCA's management provided the Office of Management and Compliance Audits with detailed explanations and the status of corrective action in process.

These financial statements will be reviewed by the School Board Audit Committee at its December 7, 2005 meeting.
