SUBJECT: REQUEST AUTHORIZATION FOR THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, TO RECEIVE AN OVERVIEW OF SECONDARY SCHOOL REFORM NEW SCHOOL OPTIONS

COMMITTEE: INSTRUCTIONAL EXCELLENCE AND COMMUNITY ENGAGEMENT

Miami-Dade County Public Schools (M-DCPS), the fourth largest school district in the nation, is committed to ensuring that our instructional programs are responsive to the needs of students, parents, and the community on local, national, and international levels. As we move forward in Secondary School Reform (SSR) efforts, the District is pursuing opportunities to significantly alter the educational experiences of students in order to meet the goals of raising the academic performance of all students; increasing the graduation rate; reducing the achievement gap; and graduating literate students who are ready for college, career, and citizenship.

One of these opportunities is the creation of small learning communities within existing secondary schools. Another is the development of small schools based on academic themes. To this end, the Special Interest Schools (SIS) Task Force, comprised of District, regional, school site administrators, teachers, community representatives, parents, and the United Teachers of Dade, was charged with developing small schools with a unique instructional focus based on career options and the demands of business and industry in South Florida. The schools proposed by the SIS Task Force include:

- Aerospace Science
- Animal Resources and Pre-Veterinary Medicine
- Art and Aesthetics
- International Finance
- International Studies
- Law Studies, Homeland Security, and Forensic Sciences
- Medical Research and Technologies
- Musical Arts of South Florida
- Olympic Education and Sport
- Real Estate, Architecture, and Construction

Other new options have already been approved by the Board, i.e., a Young Women's Leadership Academy, a Young Men's Preparatory Academy, a school with Florida Memorial University, and a partnership with the University of Miami. The chart that follows identifies possible location, number of seats and funding for the schools currently being proposed.

Student selection will follow attendance boundary priorities for students living within the area. In the event that there are remaining available seats, these will be distributed following established School Board Rules for Choice Programs. The design of both the school facility and the curricular programs will reflect a unique educational environment. These schools will be distributed throughout Miami-Dade County based on capacity needs, availability of capital funding as allocated in the Five-Year Capital Plan for 2005-2009, as well as unique opportunities to partner with appropriate non-profit, cultural, business or housing developments. At the appropriate time, each of these schools will be brought to the Board for approval.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, receive an overview of Secondary School Reform new school options.
