COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS

The purpose of this bid, opened on September 22, 2005, is to purchase, at firm unit prices, quantities, as may be required, of outdoor furniture, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 133 vendors sent bid forms or card notices of this advertised bid, 14 responded, with 5 bids meeting specifications, 2 bids not meeting specifications and 7 no bids.

Benchmarking was completed against The School Board of Broward County, Florida, bid and open-market prices, and the District's prices were found to be lower.
