The purpose of this bid, opened on December 14, 2005, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of petroleum products - oil, lubes, greases and derivatives, for the Department of Transportation, Vehicle Maintenance. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 25 vendors sent bid forms or card notices of this advertised bid, 6 responded, with 3 bids meeting specifications, 1 non-responsive bid and 2 no bids.

No bids were received for items 1A and 12A. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Benchmarking was conducted on several items against Miami-Dade County's bid, and the District's prices were found to be lower.
