**SUBJECT: AWARD BID NO. 010-FF03 – MAINLINE FOODS AND
DISTRIBUTOR SERVICES**

COMMITTEE: INNOVATION, EFFICIENCY & GOVERNMENTAL RELATIONS

The purpose of this bid, opened on March 16, 2006, is to establish a contract, to purchase, at a firm unit price, quantities, as may be required, of various dry, frozen and refrigerated food items delivered, for use in the Food Service Program of the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 414 vendors sent bid forms or card notices of this advertised bid, 7 responded, with 2 bids meeting specifications, 3 bids meeting individual item specifications, and 2 no bids.

This bid restructures the method of procuring food for the District's Food Service Program. Previously, the District awarded individual food items, which were procured by a jobber, and delivered with a markup, to the schools. This bid consolidates five separate bids for procuring food into one bid and is structured to enable the District to contract with a distribution agent for the acquisition and delivery of food items at individual fixed prices. The new format of the bid generated additional competition, resulting in a savings of approximately \$3,500,000.

No bids were received for Items P1 through P90. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Benchmarking was completed against The School Boards of Broward and Orange Counties, Florida, and the District's prices were found to be lower.
