This is a term bid which states that the Board may purchase quantities, as may be required, but is not obligated to purchase any guaranteed amount. Of 36 vendors sent bid forms or card notices of this advertised bid, 5 responded, with 5 bids meeting specifications.

Awarded vendors will be contacted, as the need arises, to offer firm fixed prices for specific jobs involving the extermination and removal of pests, including rodents, pigeons, birds, flying insects, spiders, dead animals, ants and fleas.
