**SUBJECT: REQUEST AUTHORIZATION TO NEGOTIATE AND ENTER INTO
A CONTRACTUAL SERVICES AGREEMENT BETWEEN THE
SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, AND
N/S CORPORATION, PURSUANT TO REQUEST FOR
PROPOSALS NO. 122-EE10 – BUS-WASH FACILITIES**

Request For Proposals No. 122-EE10 – BUS-WASH FACILITIES, which opened on March 30, 2006, is for the delivery, installation and maintenance of complete “turnkey” bus-wash and water-reclamation systems at specified facilities, for the Department of Transportation. This is a term proposal. Of 14 proposers sent proposal forms or card notices of this advertised proposal, 7 responded, with 5 proposals and 2 no proposals.

The Evaluation Committee met to evaluate proposals received in response to the Request For Proposals on April 10, 2006. Five (5) proposals were presented for consideration: Auto Equipment; Integrated Cleaning Systems, Inc.; N/S Corporation; Ross & White Company; and Wash Plus, Inc. After considerable deliberation, the committee recommended three (3) proposers, Auto Equipment, N/S Corporation and Ross and White Company, to conduct oral presentations. After considerable deliberation, the Committee recommended N/S Corporation for award.

The bus-wash and water-reclamation systems are to be installed at the Southwest Transportation Facility, the Northeast Transportation Facility, and the John H. Schee Transportation Facility. The base price for these systems shall be used for the purchase of any future bus-wash facilities, in addition to any retrofitting costs that may be required.
