SUBJECT: RENEWAL OF LEASE AGREEMENT WITH ROSS PARKING SYSTEMS, INC., FOR THE USE OF THE PARKING FACILITY AT SOUTH POINTE ELEMENTARY SCHOOL, LOCATED AT 1050 FOURTH STREET, MIAMI BEACH, FLORIDA

COMMITTEE: FACILITIES AND CONSTRUCTION REFORM

History

Pursuant to Board Rule 6Gx13-1D-1.01, "School Facilities – Availability to Qualified Community Organizations and Commercial Enterprises", the District is authorized to lease paved parking areas to commercial enterprises for self-parking and/or valet parking purposes pursuant to the issuance of a Request for Proposals (RFP). As a result of the RFP process, since August 2005, the Board has leased 67 paved parking spaces at South Pointe Elementary School, located at 1050 Fourth Street, for commercial parking purposes to Ross Parking Systems, Inc.(Ross), a for-profit organization, during non-school hours (see location map).

Renewal of Lease Agreement

Ross has completed its initial one-year term and has requested Board approval for the additional one-year option. This additional year represents the only one-year renewal option period available under the lease agreement. The term of the renewal option period will commence August 29, 2006, and will expire August 28, 2007.

The lease specifies that the current annual lease rate of \$30,199 shall be adjusted by either a 5% increase, or by the increase in the United States Consumer Price Index for all Urban Consumers (CPI), in effect sixty days before the anniversary of the commencement date of the lease agreement, whichever is greater. The June 2006 CPI is anticipated to be below 5%. As such, the annual lease rate will be adjusted to \$31,709 (\$39.44/per parking space/month), which reflects a 5% increase.

All terms and conditions of the lease agreement will remain unchanged, including the following:

- Ross is responsible for all repair, maintenance and upkeep of the parking facility, including litter pick-up at the end of each period of use;
- Ross is responsible for supervision of the property at all times during its period of use, and the property shall be attended at all times by at least one uniformed parking attendant; and

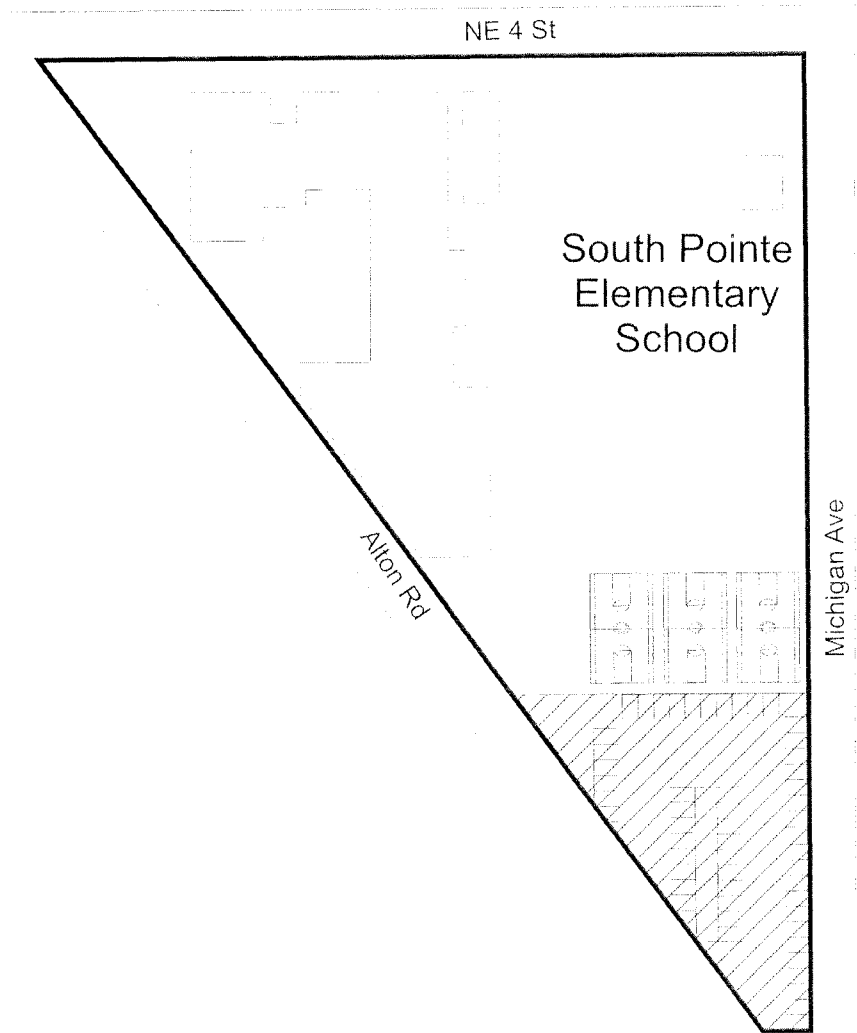
- the District may cancel the lease agreement at any time by giving Ross 30 days prior written notice.

Staff contacted the Principal of South Pointe Elementary School, the Regional Superintendent of Regional Center II and the Associate Superintendent of School Operations, who indicated no immediate after-hours need of the paved parking facilities for District purposes and recommended renewing the lease agreement with Ross for the additional one-year period.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the renewal of the lease agreement with Ross Parking Systems, Inc., for use of the parking facility located at South Pointe Elementary School, at an annual rental rate of \$31,709. The term of the renewal option period will commence August 29, 2006, and will end August 28, 2007. All other terms and conditions of the lease agreement will remain unchanged.
