SUBJECT: REQUEST AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF EDUCATION (FLDOE) FOR FUNDING UNDER THE NO CHILD LEFT BEHIND ACT OF 2001, TITLE III: SUPPLEMENTARY INSTRUCTIONAL SUPPORT FOR ENGLISH LANGUAGE LEARNERS

COMMITTEE: INSTRUCTIONAL EXCELLENCE AND COMMUNITY ENGAGEMENT

Authorization is requested to accept a grant award from the Florida Department of Education (FLDOE) in the approximate amount of \$8,425,897, to fund the No Child Left Behind Act of 2001, Title III: Supplementary Instructional Support for English Language Learners Program for the grant period of July 1, 2006, to June 30, 2007. This federal-through-state grant award is an entitlement allocation based on the total limited English proficient (LEP) students, which totaled 68,893 students in 2005-2006. The purpose of this program is to improve the education of LEP students by assisting them in learning English and meeting the challenging state academic content and student academic achievement standards. The grant is managed by the Division of Bilingual Education and World Languages.

Services provided by the grant include tutorial and mentoring, family literacy activities, parent outreach in collaboration with The Parent Academy, professional development, and career counseling. Grant funds will be used for full-time and part-time salaries, substitute teacher coverage, in-service reimbursement, instructional materials, computer hardware and software, field trips, travel, and professional and technical contracted services.

In accordance with the grant guidelines, thirty percent (30%) of the project director's salary and fringe benefits in the approximate amount of \$36,575, will be paid by the District. Funds for this item will be redirected from the ESOL non-salary budget of Fund 0100, Function 5133, Program 6600, Object 5520, Location 9905 to Fund 0100, Function 5133, Program 6600, Object 5114, Location 9609 in the General Fund of the 2006-2007 Adopted Budget.

Official notification of this grant award is anticipated on or before September 1, 2006. Reimbursement of grant-related expenditures is authorized effective July 1, 2006.

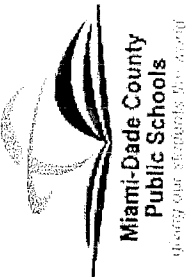
RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the Florida Department of Education (FLDOE) for funding under the No Child Left Behind Act of 2001, Title III: Supplementary Instructional Support for English Language Learners, in the approximate amount of \$8,425,897, for the grant period July 1, 2006, through June 30, 2007;
2. redirect appropriations in the approximate amount of \$36,575, from the ESOL non-salary budget to fund thirty percent (30%) of the project director's salary. The appropriation for this item is included in the General Fund of the 2006-2007 Tentative Adopted Budget;
3. extend this program as authorized through official notification from the granting agency, in order to complete the goals of the program;
4. retain funds from the grant in an amount not to exceed the annually negotiated indirect cost rate, as allowed and approved by the FLDOE; and
5. direct Financial Affairs to establish appropriations in the amounts approved or as amended by the granting agency; such appropriations to be reported periodically to the Board.
