SUBJECT: REQUEST AUTHORIZATION TO ENTER INTO TWO CONTRACTUAL AGREEMENTS WITH THE STATE OF FLORIDA, DEPARTMENT OF HEALTH, CHILD CARE FOOD PROGRAM, ADMINISTERED BY THE UNITED STATES DEPARTMENT OF AGRICULTURE, TO PROVIDE BREAKFAST, LUNCH, AND AFTERNOON SNACKS TO BABIES AND TODDLERS AT COPE CENTER NORTH AND DOROTHY M. WALLACE COPE CENTER SOUTH EFFECTIVE OCTOBER 1, 2006, THROUGH SEPTEMBER 30, 2007

COMMITTEE: INSTRUCTIONAL EXCELLENCE AND COMMUNITY ENGAGEMENT

Authorization is requested to enter into two contractual agreements with the State of Florida, Department of Health, Child Care Food Program, Administered by the United States Department of Agriculture. The purpose of the agreements is to provide breakfast, lunch, and afternoon snacks to babies and toddlers at COPE Center North, and Dorothy M. Wallace COPE Center South whose parent(s) are in attendance at the school sites. This is the second year the program is being operated at the above mentioned centers.

Food services are provided at no cost to babies and toddlers of public school students who qualify for free and/or reduced lunches. These services will ensure that babies and toddlers have a nutritional breakfast, lunch, and snack daily. These agreements will become effective October 1, 2006, through September 30, 2007.

Funding for this program will be provided by the State of Florida Department of Health, Child Care Food Program. The Child Care Food Program will reimburse a maximum of two meals and one snack per child, per day. Reimbursement is determined by the number of eligible enrolled participants who are served creditable meals. The current reimbursement rates are set by the United States Department of Agriculture. Each center involved will receive fifty percent of the reimbursements.

Mr. Phil Reeves is the Bureau Chief for the State Department of Health, Child Nutrition Program.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. enter into two contractual agreements with the State of Florida, Department of Health, Child Care Food program, administered by the United States Department of Agriculture, from October 1, 2006, through September 30, 2007;
2. provide breakfast, lunch, and afternoon snacks to babies and toddlers whose parents are in attendance at COPE Center North and Dorothy M. Wallace COPE Center South;
3. receive reimbursements for these services, of which each center will be the recipient of fifty percent of the funds issued; and
4. authorize the renewal of this contract for three successive one (1) year periods, and authorize the Superintendent to execute these annual contracts, so long as they contain the same terms and conditions as the 2006-2007 contract associated with this Item, and the renewals are at no cost to the Board.
